Thank you for joining us at the second Ukraine Action Summit, organized by the American Coalition for Ukraine! This year's Summit surpassed our first in every way, uniting even more advocates and organizations from across the country.

This Summit was a resounding success, with 303 advocates representing 34 different states and 62 partner organizations. We met with one-third of Congress, participating in 193 meetings with offices. Additionally, we gathered for panel discussions and heard from experts who provided diverse perspectives and candid insights about the fight for Ukrainian victory on all fronts. We joined a press conference announcing an important new Victory Resolution with Representatives Wilson, Cohen, and Kaptur, along with former Ukrainian President Yushchenko. This opportunity showcased our unity and enthusiasm to the world, strengthening our resolve to keep fighting for Ukraine. We made connections, shared insights, and established new areas for collaboration as we continue our work across the country.

As we continue to build on the momentum of the Summit and advocate for the support Ukraine needs today, there remains much to do. This report will serve as a valuable resource as we continue our advocacy and engage with elected officials, both local and national, and further develop meaningful connections fostered during the Summit.






Immediate Impacts on Legislation After the Ukraine Action Summit

Changes Between April 26 & May 19, 2023









Legislation Guide

HARM Act (H.R. 506 / S. 416)

The Holding Accountable Russian Mercenaries (HARM) Act is bipartisan legislation that requires the Secretary of State to designate the Wagner Group (and its affiliates and successors) a foreign terrorist organization (FTO).

Genocide Resolution (H.Res. 154 / S.Res. 72)

This resolution recognizes Russian actions in Ukraine as a genocide.

Child Deportation Resolution (H.Res. 149 / S.Res. 158)

This resolution condemns the illegal abduction of children from Ukraine to the Russian Federation.

Ukrainian Victory Resolution (<u>H.Res. 332</u> / <u>S.Res. 172</u>)

The resolution affirms that it is the policy of the United States to see Ukraine victorious against the Russian invasion, holds that the peace brought by victory must be secured by integrating Ukraine into NATO, and declares that the United States must work with its allies and partners to secure reparations, reconstruction, justice for Russian war crimes, and accountability for Russian leaders.
